How do I know if a boy is eligible?

Behavioral and Medical Considerations

Program participants must be physically, mentally, and emotionally able to cope with summer camp life and spending 3 weeks away from home. The Mayhew Program is not a clinical setting, and we do not have the staff to provide a one-on-one specialist for a boy who cannot function independently in a group setting.

If a boy has a history of acting-out sexually, fire-starting, or extremely aggressive or dangerous behavior, then it is unlikely he would be enrolled.

Additionally, Mayhew is unable to accommodate boys with major mobility issues or who need regular intravenous medication administration.

Age

We enroll boys into the program who will be 10 or 11 at the time of the summer program. While we *rarely* consider a boy who falls outside that age range, we advise you to reach out to Mayhew's Outreach Director if you'd like us to consider an exception.

Location

Please refer to the "Towns We Serve" section of the Referral FAQ page on our website (<https://www.mayhew.org/referral-faq>). If the candidate does not live in a town listed, reach out to Mayhew's Outreach Director to discuss first.

Income

Mayhew prioritizes families whose household incomes are at or below 150% of the federal poverty levels. If a boy receives free or reduced lunch at school—or if his family is a recipient of TANF or SNAP—then he will likely fall within these income guidelines. If you are unsure, please consult with the family and refer to the chart below.

While we do occasionally serve boys from households with incomes above these thresholds, please reach out to Mayhew’s Outreach Director to discuss first.

After you have sent in a referral, you should expect a confirmation email within 1 business day of receipt. You can additionally expect to be contacted by Mayhew’s Outreach Director soon thereafter. You may be asked some clarifying questions about your referral, and you will be notified whether Mayhew would like to meet the boy and his family.

- 11) Has the boy ever required physical restraint? If so, in what circumstances? How frequently?

12) Please describe the boy's PERSONALITY and SOCIAL STANDING. *Is he introverted/extroverted? A leader/follower? How does he respond to authority? How does he interact with his peers? How's his self-esteem?*

13) Please describe the boy's BEHAVIORAL PATTERNS: *Does he have a specific plan for deescalating behaviors? Are there specific cycles of behavior that the boy frequently engages in? For example, does he typically get into fights and then claim that he was only reacting to the behavior of others? Does he talk about how terrific he is in some sport only to let himself and others down when it comes to actually doing it? In short what does he do that is particularly frustrating, disconcerting or conversely, charming or disarming?*
